## Introduction

---

Our firm, Meridian Wealth Advisors is registered as an investment adviser with the U.S. Securities and Exchange Commission. ## Relationships and Services

---

### What investment services and advice can you provide me?

**Services:** We offer investment advisory services to retail investors. These services include wealth management which is a combination of financial planning and investment management. We may also offer investment management, asset allocation, financial planning and financial consulting as stand-alone services. We work closely with you to identify your investment goals and objectives, as well as risk tolerance and financial situation in order to develop an investment approach.

**Accounts, Investments, and Monitoring:** We provide services to individual, joint, retirement, trust and estate and donor advised accounts. We primarily use exchange-traded equities, corporate bonds, municipal bonds, certificates of deposit, mutual funds, independent managers, real estate investment trusts and alternative investments in constructing portfolios. We do not make available or offer advice with respect to only proprietary products or a limited menu of products or types of investments. As part of our services, we monitor portfolios and securities in accounts on a regular and continuous basis. We also meet with you at least annually, or more frequently, depending on your needs.

**Investment Authority:** We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives without your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing. We also offer our services on a non-discretionary basis, which means we are required to obtain your consent prior to executing any trades in your accounts. Therefore, you will make the ultimate decision regarding the purchase or sale of investments in your accounts. However, we may not be able to aggregate your order with other client orders under this type of authority and therefore you may not receive the same price as other clients.

**Account Minimums & Other Requirements:** We generally require a minimum relationship size of \$2,500,000 and a minimum fee of \$12,500 in order to effectively implement our investment process. This amount may be waived or reduced at our sole discretion.

## Fees, Costs, Conflicts, and Standard of Conduct

---

### What fees will I pay?

**Asset-Based Fees:** Our asset-based fees for wealth management and investment management range up to 1.00% annually based on a tiered schedule. This fee is collected on a quarterly basis and calculated as a percentage of the value of the cash and investments in your account[s] that we manage. This presents a conflict of interest as we are financially incentivized to encourage you to place more assets in your advisory account as you will ultimately pay more in advisory fees. We are a fiduciary, and as such we are obligated to provide advice and guidance that is in your best interests.

**Fixed Fees:** Our fixed project-based fees for financial planning and financial consulting range from \$5,000 to \$100,000. We collect these fees in a single installment. Our fixed project fees for asset allocation services range from \$5,000 to \$15,000. This fee is collected in quarterly installments. Fixed fees are negotiable based on the nature and complexity of the services to be provided and the overall relationship with us. We provide you with an estimate of the total cost prior to engaging us for these services.

**Other Fees & Costs:** In addition to our advisory fee, you will also be responsible for third party manager and/or platform fees, custody fees, account administrative fees, fees and expenses related to mutual funds and exchange-traded funds and applicable securities transaction fees.

**Additional Information: You will pay fees and costs whether you make or lose money on your investments.** Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. #### **What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?**

*When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.*

Some of our financial professionals are licensed as insurance agents. In addition to our services, your financial professional may offer you insurance products in their separate capacity as an insurance agent. The fees charged for the implementation of insurance products are separate from our advisory fees, where your financial professional will earn commission-based compensation for the implementation of an insurance product. Therefore, there is a financial incentive to recommend that you implement insurance through our financial professionals.

#### **How do your financial professionals make money?**

Our financial professionals who are not partners are compensated based on an agreed-upon annual salary. Additionally, they may receive a discretionary bonus based on their overall performance.

Our financial professionals who are partners in the firm are compensated based on the revenue generated from advisory services, which is distributed in accordance with our partnership agreement. This means our financial professionals who are partners have an incentive to increase the asset size in the relationship or solicit new business, taking time away from the day-to-day servicing of existing clients.
